Solid Fuel Stove Procedures

(Wood, Pellets, Coal, etc.)

When a new or used solid fuel stove is installed in the existing or new chimney or fireplace the following must be done prior to an inspection.

- ✓ The stove **MUST** be UL (or equivalent independent testing organization) listed, with the label attached to the stove. The fire department will not inspect homemade or unidentifiable stoves.
- ✓ Obtain a certificate of inspection from a ***Chimney Cleaning Company*** stating they have cleaned and inspected the chimney, removed the damper if installed in a fireplace & the chimney is safe for use with the stove.
- ✓ Installers must provide their Construction Supervisors License (CSL) Number and/or Home Improvement Contractor (HIC) Number and Certificate of Insurance.
- ✓ Installation manual must be on site and available for inspection.
- ✓ Stove must be installed to the manufacture's specifications.
- ✓ If wall protectors are used, supply a drawing with details.
- ✓ Must meet Building Code 780 CMR 3610, 108.3.5, 110, 111 Regulations R5, R6, Appendix K & NFPA 211
- ✓ Smoke & Carbon Monoxide Alarms must be under 10 years old and installed in proper locations.
- ✓ A completed permit application must be submitted to the fire department prior to an inspection.
- ✓ Contact the Fire Department for the site inspection after installation is complete at (508) 869-2342.
- ✓ Inspection fees are \$50.00. Checks are payable to the "Town of Boylston".
