GENERAL BUSINESS

AGENT'S REPORT

<u>FY 2016 Budget</u> – Sarah and Dennis met with the Finance Committee. The budget was accepted as presented.

<u>Annual Report</u> – Sarah will contact Lori Esposito to see if there is still time to submit the annual report.

<u>Mosquito Control</u> – A requirement to the State Reclamation & Mosquito Board is for member cities and towns to sign a Declaration of Support or No Support of Mosquito Control Funding for FY 2016. The board is in support. Dennis will sign the document and forward to Timothy Deschamps, Executive Director.

<u>Tobacco</u> – The initiative of the Tobacco21 group is to raise the purchasing age for tobacco from 18 to 21. It is believed that the brain is more susceptible to nicotine addiction before the age of 21. The state age is 18, but some individual towns have changed the age to 21. Nicotine is the addictive factor in tobacco. Nicotine is unregulated; tobacco is regulated. The Tobacco21 group will be invited to attend the March meeting.

Dennis attended a DPH meeting where the discussion was opiate heroin overdosing. It is no longer an inner-city problem; it's in the suburbs and needs to be addressed more in the smaller communities. There is an antidote (Narcan) that can be administered fairly quickly in order to work. Dennis will do more research and Sarah will contact the school nurses and Joe Flanagan.
