SUBMITTAL REQUIREMENTS

Upon completion, the applicant must provide the Commission with certification that the project was completed per the approved plans and that all conditions were met. Details on what is required for the certification is listed in the Stormwater Control Bylaw Regulations.

The applicant must also provide the Commission with detail as to who the responsible parties for the implementation of the ongoing operation and maintenance plan will be, and that they understand the requirements of the plan, including inspection reports, and stormwater management facility maintenance.

If the provided information is satisfactory, the Commission will issue a Certificate of Compliance. This Certificate of Compliance will include ongoing conditions such as implementation of the maintenance plan.
