

### Information for the Residents of Boylston during the COVID-19 Outbreak

During this trying time the health and safety of the residents of Boylston is the number one priority. Below you will find information regarding the services of most town departments as well as some resources to help those who may need assistance. We encourage everyone to follow the guidelines laid out by the CDC and Governor Baker. In the meantime, your town is here for you and we encourage you to reach out with any needs. ## **Boylston Fire Department**

Regarding the COVID-19 virus, it is important that we stress that this isn't a time to panic and that residents should follow the guidance set forth by MA DPH and the CDC. Unfortunately, people get most of their information from social media and that isn't always the most accurate source. The BFD Facebook page has a link to the CDC website and that site has daily updates on the virus. In addition, there is information on the mass.gov site that links to MA DPH and CDC. The fire department has limited personal protective equipment to handle a few patients, if needed. We are in the process of trying to get additional equipment just in case there is a large influx of patients, although we hope that will not be the case. We believe if residents practice good hygiene and use common sense in terms of social distancing then the risk should be minimal. Please rely on the experts at the CDC and DPH for their information, rather than social media.

One thing that would be helpful for us would be that in the event that someone feels like they meet the criteria for exposure (flu-like symptoms, recent travel, or contact with someone who was exposed) that they let us know when they call 911 to request an ambulance. It is critical for us to know the potential exposure prior to us going into a home so that we can take the necessary precautions to protect our people.

### **Boylston Police Department**

During this period of increased health challenges due to the flu or Coronavirus, the Boylston Police Department will continue to provide 24-hour, 7 day a week law enforcement support to the Town of Boylston. In an effort to reduce the spread of the COVID-19 illness, our department will be taking the following steps immediately:

We will continue to respond to ALL emergency calls without delay. If you have an emergency, dial 911 and officers will respond as always!!!

If it is a non-emergency, you are encouraged to call the business line for assistance at 508-869-2113.

Our dispatchers and/or police officers responding to your calls/homes may ask some pre-screen questions regarding potential illnesses before entering. These questions are not invasive and are meant to keep both you and our police officers safe during the COVID-19 global pandemic.

Calls for police services will be screened to determine if an immediate police response is needed. In most cases, where applicable and possible, we will try to take reports via the telephone, especially where there is a past event (identity theft, credit card fraud, quality of life reports, etc).

Citizens who walk into our lobby will also be screened to determine if a phone report is applicable. In some cases, it may be appropriate to conduct an interview or take a report outside of the police station building and away from our common lobby area.

We encourage citizens to call our department via telephone ahead of time before travelling to the police station to make/file a report. In many cases, a police officer can and most often will take care of a citizen's needs by phone, and thus reduce the chance of spreading the COVID-19 illness.

Our department will be suspending taking ANY new License to Carry (LTC) applications. Renewal applications for all LTC applications will also be suspended unless your LTC is about to expire. If your current LTC is about to expire, please contact police dispatch (508-869-2113) and schedule an appointment with Sergeant Thomas. Please DO NOT enter our building to renew your LTC without an appointment.

ANY requests for copies of police reports should be made by calling the police station between the hours of 9:30AM and 3PM, Monday through Friday at 508-869-2113.

Fingerprint services (card) for the public will be suspended until further notice.

The Boylston Police Department sincerely regrets having to take these precautions. Our department takes great pride in being police officers and community caretakers for the Town of Boylston. The ever changing COVID-19 situation makes these precautions unfortunately necessary to keep our police officers, dispatchers and the public safe, while not hindering our ability to provide critical police services to you.

We anticipate taking these actions until March 30, 2020, when we will re-evaluate the ever-changing situation with the COVID-19 illness. Your cooperation and understanding is greatly appreciated!

"Effective on Thursday, March 19, Stop & Shop will create hours specifically geared to accommodate customers 60 and older," the company said in a statement. ### **Meals on Wheels**

Meals on Wheels and our transportation services will continue to operate through the Council on Aging at this time *for medical appointments only*, but may be subject to change. We are continuing to evaluate if we can provide a meal take out service to those who regularly come to the senior center to eat.

### **Town Hall**

In response to the Coronavirus, and in consideration of information from the Centers for Disease Control and Prevention (CDC), Massachusetts Department of Public Health, the declaration of a State of Emergency in Massachusetts by Governor Baker on March 10, 2020, and the Executive Order Suspending Certain Provisions of the Open Meeting Law issued by Governor Baker on March 12, 2020, the Boylston Town Hall, Boylston Town House, and all other buildings with the exception of the Police and Fire Stations for emergency services will be closed to the public from Monday, March 16th through Friday, March 27th, 2020. The status will be evaluated at a later date if further closing is necessary. The staff will be available during normal hours of operation (Town Hall 8:00am – 2:00pm) Monday through Thursday to answer phone calls or email questions from the public.

The closure of the Town Hall will impact those seeking services from all departments operating at the Town Hall. Town offices may be contacted by telephone or e-mail. Please visit the Town website for a directory at <a href="https://www.boylston-ma.gov">www.boylston-ma.gov</a>.

Residents and other interested parties can drop off bills, applications for permits and licenses at the drop box located at Town Hall and access other information and services at the Town Website. Payments by check will still be accepted through the drop box located to the right of the main entrance of the Town

Hall. Cash is not accepted. Department-specific operational changes will be posted to their respective webpage on the Town website <a href="https://www.boylston-ma.gov">www.boylston-ma.gov</a>.

Motor Vehicle Excise:

- Application: Please fill out the application on the back of the bill or download from our website. (We can mail you one if needed.)
- Plate: We need to know what happened to the license plate, for example:
  - o If plate was transferred to a new car, please provide a copy of the new registration.
  - If plate was cancelled, please provide a copy of the Plate Return Receipt from the registry.
- Vehicle: We need to know what happened to the vehicle, for example:
  - If Vehicle was traded in, please provide a copy of the Purchase and Sale agreement showing the trade (with the VIN)
  - o If Vehicle was sold outright or junked, please provide a copy of the Bill of Sale.
  - If vehicle was totaled in an accident, please provide a copy of the letter from the insurance company.
