## **APPLICATION PROCESS**

The Planning Board meets on the first Monday of every month unless otherwise noted. See below for meeting schedule for 2023-2024.

All applications for any of the following must be submitted according to the table below to allow sufficient time for review and placement of ad (if applicable):

ANR Plan Site Plan Review Special Permit Definitive Subdivision Preliminary Subdivision

Applications must <u>first</u> be submitted electronically to the Town Planner (<u>pdellaquila@boylston-ma.gov</u>), who will review the application for completeness.

## DO NOT SUBMIT HARD COPIES OF ANY APPLICATION MATERIALS UNTIL DIRECTED TO DO SO BY TOWN STAFF.

Once the Application is determined to be complete by the Town Planner, applicants will submit hard copies of the signed application forms, supporting plans and materials, and fee payment to the Planning Board, Boylston Town Hall, 221 Main Street, Boylston, MA 01505 (email: <a href="mailto:ngardner@boylston-ma.gov">ngardner@boylston</a>. The number and size of the hard copies to be submitted will be determined by the Town Planner. Please note that full-size plans must be folded, not rolled.

The applicant must also obtain a certified abutters list from the Assessor's Office if a public hearing is required and provide a copy of the abutters list along with the application package.

The applicant will be responsible for notifying the abutters by certified mail with return receipt and then provide proof of notification to the Planning Board.

The Town will place the public notification ad in the Telegram and Gazette.

Any other requests to be on the agenda for a meeting must be submitted in writing no later than 2:00 p.m. on the Tuesday before the scheduled meeting.
