Possible Productions Inc. is currently in pre-production on an original series for Showtime titled "Marble"; a 10-part limited series of the popular show *Dexter*. Starring Michael C. Hall (*Dexter, Gamer, & Six Feet Under*) and Jennifer Carpenter (*Dexter, The Enemy Within, & Limitless*) the series will be directed by Marcos Siega (*Dexter, The Following, God Friended Me*) & Sanford Bookstaver (*Chicago Fire, Power, Jessica Jones*). The show will also be Executive Produced by Michael C. Hall.

We are interested in staging a controlled single car "crash" scenes on MA-140 (aka Temple St & W Boylston St) between Main St (MA-70) & Maple St in the Cities of Boylston and West Boylston, respectively. The scene is scripted to take place during the daytime and we would require a traffic diversion to conduct the work.

Currently our schedule is in flux as we are in the pre-production phase but at this time we anticipate filming to take place for approx. two days (approx. 1 day each scene) in February to March 2021.

Production company: Possible Productions Inc.

Production name: "Marble"

Shoot date & times: Approx. 2 days in February 2021 to March 2021. Potentially non-consecutive days.

CRASH SCENE

Character struggles with the kidnapper as the vehicle swerves and plows into a staged "prop" sign & barrier. Character is ejected from the car, head first.

Working with a traffic diversion, DAYTIME filming of a single car "crash" scene performed by professional stunt actor & driver under the supervision of Stunt Coordinator Jeffrey Lee Gibson (*Vinyl, Point of Interest, 21 Jump Street*). "Crash" vehicle to be safety fitted & rigged with minimal hazardous substance (eg. Low fuel & no leaking fluids).

Please see below the following requests for our proposed plan of action:

- Divert vehicular & pedestrian traffic, except emergency vehicles, on MA-140 (aka Temple St) & Maple St from approx. 7AM-7PM during filming date(s). Please see attachment for suggested traffic control map.
- Divert vehicular & pedestrian traffic, except emergency vehicles, on MA-140 (W Boylston St) between Main St (MA-70) from approx. 7AM-7PM during filming date. Please see attachment for suggested traffic control map.
- "Crash" scene to be staged on MA-140. (Please see attachment showing the location of the crash scene)
- Stage "prop" sign & barrier at selected "crash" location to complete the scene.
- Request to remove wooden fencing allowing the road for our scene. Will restore the fence when, please let us know how to proceed. (Picture attached below)
- Utilize Russian-Arm camera vehicle & drone during "crash" scene filming. (Picture attached below)
- Perform controlled "crash" scene with professional stunt coordinator, actor, & driver with safety & environmental appropriate vehicle.

- Stage variable message board at selected location(s) to provide traffic diversion notification in advance of filming.
- Town of Boylston and West Boylston police assistance for traffic diversion during filming date(s)
- Fire & Medical supervision & assistance for “crash” filming date.
- Ability to present various scheduling scenarios to be able to adjust accordingly based on weather or any other unforeseeable conditions, as necessary

Please note that Possible Productions Inc. has and will continue to institute a robust Covid-19 mitigation protocol. This includes education, cast & crew testing on a regular weekly (or more) cadence, proper use of PPE and social distancing. 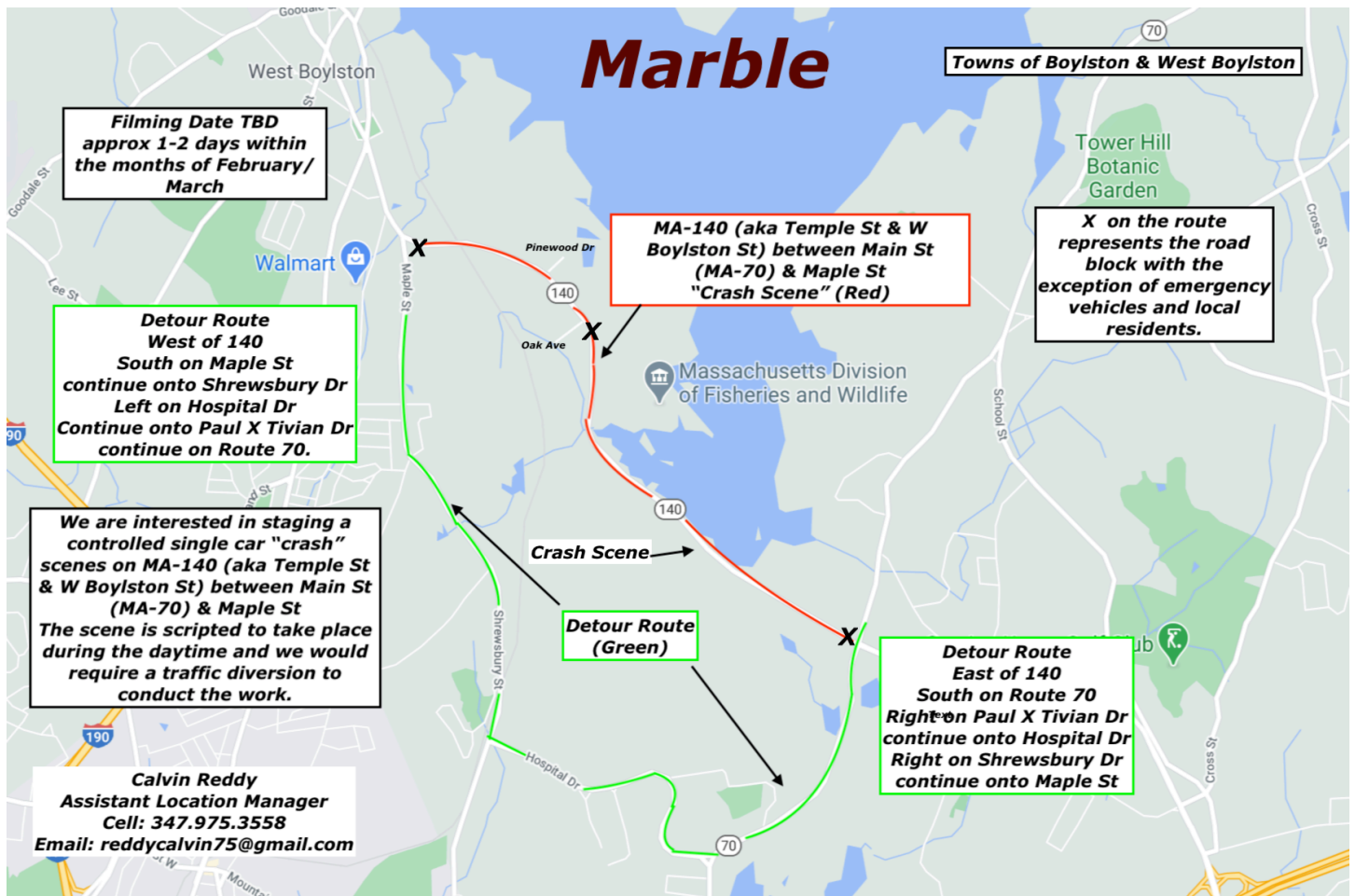
