- List of abutters (300'), certified by the Assessors Office (proof of abutter notification must be provided at the time the Public Hearing is opened);
- Stormwater Management Plan and project description;
- Operation and Maintenance Plan;
- Inspection and Maintenance Agreement;
- Erosion and Sediment Control Plan; and
- Surety bond (if required).

D. Fees

The fees for work proposed under each Stormwater Control Permit Application must be calculated and submitted to the Conservation Commission as outlined in Section 6.0 Part C of the Town of Boylston Stormwater Control Bylaw Rules & Regulations.

Application Fees are determined by the land area that will be disturbed by activities authorized by the Stormwater Control Permit per Section 6.0 Part C.3 of the Rules & Regulations, as listed below:

For up to two (2) acres of disturbed land, a \$100.00 Application Fee is due.

For two (2) acres or greater of disturbed land, a \$200.00 Application Fee is due.

No fee shall be assessed for projects of the federal government, state government, and municipal agencies and departments.
